### CSTS-09 and CSTS 2020

### Information Sheet for Facilitators

#### What is CSTS 2020?

CSTS 2020 is the upgraded version of CSTS-09. CSTS 2020 is comprised of nine standard modules grouped together and called *CSTS Fundamentals* and site-specific Add-on Modules. On its own, *CSTS Fundamentals* serves as a general construction site orientation for workers new to the construction industry. It is supported by a number of job-specific Add-on Modules to help employers customize CSTS training to fit specific site requirements.

### Why did we upgrade CSTS-09?

CSTS was last revised in 2009, and much of the information in CSTS-09 is now outdated. CSTS 2020 includes the most recent legislated changes to Alberta's *Occupational Health and Safety Act*, and reflects current industry best practices.

### How have we improved CSTS?

CSTS 2020 (by December 31, 2020):

- includes CSTS 2020 *Fundamentals* with 9 modules, and we anticipate adding an additional 20 Add-on Modules by December 31, 2020, plus more to be added on an ongoing basis.
- includes Add-on Modules which range between 5 to 15 minutes each and can be taken separately.
- allows employers to customize their site orientation to meet their needs. We will continue working to offer the most current legislative and industry standards in Add-on Modules in coming years.
- is inclusive of industrial, commercial, and residential construction site best practices.
- refers to Alberta's recently updated Occupational Health and Safety Act.
- high quality training videos utilized in the program are free to download for use in site training, refresher training, toolbox talks, etc.
- utilizes current online training best practices to provide a much more time efficient fundamental orientation:
  - CSTS 2020 Fundamentals Course is 2 to 3 hours long compared to CSTS-09 that is 8 to 9 hours long, and
  - CSTS 2020 is mobile friendly!! Internet access is required for use on any device.
- will be offered exclusively (and openly) on our learning management system, allowing workers to always have access to their training certificates.
- this is NOT a Flash-based product (support for Flash ending soon).

### How long will CSTS-09 and CSTS 2020 be offered FREE of charge?

CSTS-09 will be available free of charge from September 3 to December 31, 2019—after which it will be retired.

CSTS 2020 will be available free of charge from September 9, 2019, to December 31, 2020.

### Does CSTS-09 certificate of completion expire after it is retired on January 1, 2020?

No, there is no expiry on CSTS-09.

**Do I need to enter a coupon code to get CSTS-09 and CSTS 2020 courses for FREE?** As a facilitator, you will need to use the coupon code **CSTSFREE** to get the FREE CSTS courses. Please enter this coupon code on the Shopping Cart page *before* Proceeding to Checkout. The coupon code will work for CSTS-09 and CSTS 2020 *Fundamentals* and Add-on Modules.

# Do my workers/students need to complete CSTS 2020 if they have already completed CSTS-09?

We do not have a requirement for workers/students to complete CSTS 2020. As with any training, employers are responsible to determine their own site access requirements. By January 2020, CSTS 2020 makes available all information (updated) that is included in CSTS 09, plus much more in optional modules. Module selection is customizable by employer/industry group.
